AT FIRST, IT WAS SPECIALIZED IN THE BANKING SYSTEM REFORM, THE LIBERALISATION OF PRICES, OR EVEN THE CHERNOBYL DISASTER IN UKRAINE. SLOWLY, THE EBRD STARTED TO EXPAND ITS REGIONS: MONGOLIA (2006), TÜRKIYE (2009), EGYPT, JORDAN, MOROCCO, TUNISIA AND KOSOVO (IN 2012), CYPRUS (2014), GREECE (2015) AND LEBANON (2017). EVEN THOUGH RUSSIA USED TO BE THE EBRD'S LARGEST COUNTRY BY BUSINESS VOLUME, THE BANK CUT ITS BUSINESS THERE. UNIQUELY FOR A DEVELOPMENT BANK, THE EBRD HAS A POLITICAL MANDATE IN THAT IT ASSISTS ONLY THOSE COUNTRIES 'COMMITTED TO AND APPLYING THE PRINCIPLES OF MULTI-PARTY DEMOCRACY [AND]PLURALISM'. MORE RECENTLY, THE GREEN ECONOMY TRANSITION APPROACH OF THE BANK HAS MADE CLIMATE FINANCE A KEY MEASURE OF THE BANK'S PERFORMANCE.




